A BILL

To amend title 10, United States Code, to prohibit certain adverse personnel actions taken against certain members of the Armed Forces based on declining the COVID–19 vaccine.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “COVID-19 Vaccine
5 Dishonorable Discharge Prevention Act.”.

1 **SEC. 2. PROHIBITION ON ADVERSE PERSONNEL ACTIONS**
2 **TAKEN AGAINST CERTAIN MEMBERS OF THE**
3 **ARMED FORCES BASED ON DECLINING**
4 **COVID-19 VACCINE.**

5 (a) FINDINGS.—Congress finds the following:

6 (1) The Secretary of Defense has announced a
7 COVID-19 vaccine mandate will take effect for the
8 Department of Defense.

9 (2) Reports of adverse actions being taken, or
10 threatened, by military leadership at all levels are
11 antithetical to our fundamental American values.

12 (3) Any discharge other than honorable denotes
13 a dereliction of duty or a failure to serve the United
14 States and its people to the best of the ability of an
15 individual.

16 (b) PROHIBITION.—Chapter 55 of title 10, United
17 States Code, is amended by inserting after section 1107a
18 the following new section:

19 **“§ 1107b. Prohibition on certain adverse personnel**
20 **actions related to COVID-19 vaccine re-**
21 **quirement**

22 “(a) PROHIBITION.—Notwithstanding any other pro-
23 vision of law, a member of an Armed Force under the ju-
24 risdiction of the Secretary of a military department sub-
25 ject to discharge on the basis of the member choosing not

1 to receive the COVID–19 vaccine may only receive an hon-
2 orable discharge.

3 “(b) MEMBER OF AN ARMED FORCE DEFINED.—In
4 this section, the term ‘member of an Armed Force’ means
5 a member of the Army, Navy, Air Force, Marine Corps,
6 or the Space Force.”.

7 (c) CLERICAL AMENDMENT.—The table of sections
8 at the beginning of such chapter is amended by inserting
9 after the item relating to section 1107a the following new
10 item:

“1107b. Prohibition on certain adverse personnel actions related to COVID–19
vaccine requirement.”.
