3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “I-27 Numbering Act
5 of 2023”.

6 **SEC. 2. NUMBERING OF DESIGNATED FUTURE INTERSTATE.**

7 (a) IN GENERAL.—Section 1105(e)(5)(C)(i) of the
8 Intermodal Surface Transportation Efficiency Act of 1991
9 (Public Law 102-240; 109 Stat. 598; 133 Stat. 3018) is
10 amended by inserting after the tenth sentence the fol-

1 lowing: “The routes referred to in clause (i) (other than
2 subclauses (V)(aa) and (V)(bb) and subclause (IX)(aa) of
3 that clause) and clause (iv) of subsection (c)(38)(A) are
4 designated as Interstate Route I-27. The route referred
5 to in subsection (c)(38)(A)(i)(V)(aa) is designated as
6 Interstate Route I-27E. The route referred to in sub-
7 section (c)(38)(A)(i)(V)(bb) is designated as Interstate
8 Route I-27W. The route referred to in subsection
9 (c)(38)(A)(i)(IX)(aa) is designated as Interstate Route I-
10 27N.”.

11 (b) CONFORMING AMENDMENTS.—Section
12 1105(c)(38)(A)(i) of the Intermodal Surface Transpor-
13 tation Efficiency Act of 1991 (Public Law 102-240; 105
14 Stat. 2032; 114 Stat. 2763A-201; 116 Stat. 1741) is
15 amended—

16 (1) in subclause (V)—

17 (A) by striking “Lamesa, the Corridor”
18 and inserting the following: “Lamesa—

19 “(aa) the Corridor”; and

20 (B) in item (aa) (as so redesignated), by
21 striking “87 and, the Corridor” and inserting
22 the following: “87; and

23 “(bb) the Corridor”; and

24 (2) in subclause (IX)—

1 (A) by striking “(IX) United States Route
2 287” and inserting the following:

3 “(IX)(aa) United States Route
4 287”; and

5 (B) in item (aa) (as so redesignated), by
6 striking “Oklahoma, and also United States
7 Route 87” and inserting the following: “Okla-
8 homa; and

9 “(bb) United States Route 87”.
